The meeting was called to order at 8:12 p.m. by Mrs. DeLauter. Mrs. DeLauter led everyone in the Pledge of Allegiance. Mrs. DeLauter stated Mrs. Schwartz could be here tonight because she is being honored as Teacher of the Year in the district where she works.

CALL TO ORDER

Dr. Kaplan moved that the Board of Education approve the minutes from the January 8, 2014 Board of Education meeting. Mrs. Lanci seconded and the motion was carried 7-0. Dr. Kaplan moved that the Board of Education approve the minutes from the January 22, 2014 Board of Education meeting. Mrs. Lanci seconded and the motion was carried 6-0-1 with Mrs. Goller abstaining. Dr. Kaplan moved that the Board of Education approve the minutes from the January 31, 2014 Board of Education meeting. Mrs. Lanci seconded and the motion was carried 5-0-2 with Mrs. Goller and Mr. Haile abstaining.

**MINUTES** 

Dr. Kaplan moved that the Board of Education approve the Treasurer's Report, dated December 31, 2013. Mrs. Blane seconded and the motion was carried 7-0. **REPORT** 

TREASURER'S

Mr. DeTommaso welcomed everyone and stated he is happy to recognize students, teachers and Board members. The District's Intel Science Research has produced incredible results with three semi-finalists this year.

SUPERINTENDENT'S REPORT

**SUPERINTENDENT'S** REPORT (Continued)

Mr. Robert Soel stated the District's Science Research Program students put in over 400-500 hours with mentors in the scientific community. Over the past ten years, the District has had 53 semi-finalists, 34 from JFK. He thanked the Board for their support.

**INTEL SEMIFINALISTS** Dr. Kuschner presented an Award of Honor certificate to Kennedy High School senior Rachel Abramowitz for having been named a semifinalist in the 2014 Intel Science Talent Search. The title of Rachel's project is: Why Innocent People Comply with Police Requests: The Role of Just World Beliefs and Public Self Consciousness. Since 2005, the rate at which innocent people confess to crimes has increased significantly. Previous studies have suggested two theories to explain why people choose to falsely confess: Illusion of Transparency and Just World Hypothesis. 80 subjects completed surveys to determine whether or not they believed in these theories. Subjects were randomly placed into a scenario where they were innocent or guilty of a crime. All participants were considered suspects and asked a series of questions by police to assess cooperation. Her research indicates that for eight out of nine questions, innocent people were significantly more cooperative than guilty people. Rachel is a member of three honor societies and has received numerous academic awards, including an AP Scholar Award. She has been a member of the District Varsity Swim Team for six years and has played on the JV and Varsity Lacrosse teams. Rachel is an active fund raising participant in the B'Nai Brith Youth Organization and her community service activities include the Avon Breast Cancer Walk, Polar Bear Club for Make-A-Wish Foundation and a past captain for Relay for Life. In her spare time Rachel baby-sits and does peer tutoring. She hopes to become a Clinical Psychologist. On behalf of the Board of Education, Dr. Kuschner congratulated Rachel and the Kennedy Advanced Science Research teachers, Mrs. Barbi Frank, Mrs. Barbara Franklin, and Mr. Helmut Schleith.

> Mrs. Goller presented an Award of Honor certificate to Kennedy High School senior Rebecca Jellinek for having been named a semifinalist in the 2014 Intel Science Talent Search. The title of Rebecca's project is: The Effects of Barbie Dolls and Their Wardrobes on Body Dissatisfaction. Playing with Barbie dolls has been linked to poor body image in young girls. The present study is the first to determine if doll clothing and doll familiarity affect young girls' body images. Participants completed body image surveys and played with a Barbie doll and full-figured doll of unequal familiarity. In a follow-up study, participants completed body image surveys and played with a thin doll and fullfigured doll of equal unfamiliarity. The doll type affected body image the most when playing with unfamiliar dolls; however, clothing type had no effect on body image. Playing with thin dolls resulted in a great disparity between one's ideal shape and one's actual shape, which may contribute to development of eating disorders. Rebecca is a member of six honor societies and has received numerous Science and Math awards, including first place winner in the 2013 She is president of the Drama Club, New York State Science Congress. Women's Choir, Concert Choir and a member of Student Government, Variety Choir and the NYSSMA 2014 All-County Women's Choir. She is a peer tutor

and a volunteer at Winthrop University Hospital. Rebecca plans to pursue medicine in college. Mrs. Goller congratulated Rebecca and also the Kennedy HS Advanced Science Research teachers on behalf of the Board of Education.

INTEL SEMIFINALISTS (Continued)

Dr. Kaplan presented an Award of Honor certificate to Kennedy High School Salutatorian Benjamin November for having been named a semifinalist in the prestigious 2014 Intel Science Talent Search Competition. The title of Ben's project is: Measurement Of Leaf Properties To Improve The Parameterization Used By Earth System Models To Estimate The Maximum Capacity for CO2 Uptake In the Arctic. Earth System Models (ESMs) are used to project future climate change. These models inaccurately measure the maximum rate at which the enzyme Rubisco can fix CO2 in plants (Vc,max). This imprecision is especially high in the Arctic. This study analyzed the values of Vc,max in 11 arctic plant species across five categories. The values of Vc,max calculated in this study were on average 74% higher than the Community Land Model, a popular ESM. This can be attributed to the differences in the carbon to nitrogen ratio and the specific leaf area calculated in this study and in some ESMs. The projections of global climate change may be skewed and require further analysis of variables to improve their accuracy. Ben is a member of four honor societies and an AP Scholar with honors. He has been a four year member of the spring Track Team, and has played football. He is also a member of Future Business Leaders of America (FBLA), Athletes Helping Athletes, the math team, and the chairperson of the Stock Market Club. He has volunteered at Winthrop University Hospital and has been a math, science and SAT tutor. Ben wants to become an engineer and hopes to obtain his Masters and PhD degrees. On behalf of the Board, Dr. Kaplan congratulated Ben and the Science Research teachers.

> CHANNEL 12 NEWS SCHOLAR/ATHLETE

Mrs. DeLauter presented an Award of Honor certificate to Mepham High School senior Brian Keohane for having been selected to receive the Channel 12 News Scholar Athlete of the Week Award. He was chosen for this award for his outstanding ability in athletics, scholarship, leadership, and service. Brian will receive a \$1,000 scholarship and is one of only 30 students from Long Island chosen for this prestigious honor. Brian, the Valedictorian of the Class of 2014, has received numerous awards and honors and was named a semifinalist in the National Merit Scholarship Competition. Most recently, he has been named a candidate in the prestigious 2014 US Presidential Scholars Program. His passion for science has earned him many accolades including winning the 2013 Long Island Physics Olympics. He is a successful member of the Science Olympiad Team and has earned induction to virtually every honor society. Brian is a volunteer tutor for his classmates through the Peer Tutors program and makes presentations at the elementary schools with Athletes Helping Athletes. He is a three season varsity athlete on the track, cross country, and basketball teams. Brian's devotion of countless hours to community service throughout the school and community is limitless, and with his sense of loyalty and compassion, it is not surprising that he has been awarded the Channel 12 News Scholar Athlete of the Week Award. Mrs. DeLauter congratulated Brian and his coaches on behalf of the Board of Education.

Mr. Harrington, Principal of Mepham High School, advised Brian is now a National Merit Scholarship finalist.

## NASSAU COUNTY "GOLDEN ELEVEN" SCHOLAR/ATHLETE

Mrs. Lanci presented an Award of Honor certificate to Mepham High School senior Christopher Durkin for having been chosen as a Nassau County "Golden Eleven" Scholar Athlete. Chris truly exemplifies the term scholar athlete and is a positive role model for all to emulate. His academic program demonstrates the height of rigor that our school district has to offer, consisting of a high concentration of honors, advanced, and Advanced Placement courses. It is no surprise that he has been inducted into several honor societies and has received countless accolades across the academic disciplines. He serves as a student representative on the site-based committee, volunteers with Habitat for Humanity, and is a constant fixture at school-wide events. Athletically, Chris capped off an outstanding football career with one of the finest seasons of any player in Nassau County. He led the Mepham team with 97 unassisted tackles and three sacks on the defensive side and offensively Chris rushed for 709 yards and seven touchdowns with seven yards per attempt average. Varsity Wrestling and a Rifle Team member competed in the NYS competitions. Kennedy's Science team placed 9<sup>th</sup> out of 42 teams recently. Junior class experienced an assembly about good decisions while driving or as a passenger in a vehicle. Kennedy had several PTA Reflections winners. One will go on to the national competition. 9<sup>th</sup> graders attended an assembly on bullying. February 27<sup>th</sup> is Class Night.

Mr. DeTommaso thanked the Merrick Avenue Middle Schools Art Department for the display in the central office corridor. He spoke about the NYS Regents' 18 Common Core adjustments, some of which the Governor opposes. The NYS legislature has decided to also weigh in on this topic. I n Bloom has definitely been delayed for one year. He mentioned the NYS Budget and what is in store for education and Bellmore-Merrick next year. The legislature is looking into the funding for Pre-K and the implications for districts that have full and half day pre-kindergarten programs. He stated the Gap Elimination Adjustment (GEA) in 2009 took away district money but promised to return that money. Bellmore-Merrick is down 3.6 - 3.7 million dollars. Hopefully, in this election year, the divide between the legislature and the governor will be solved. At the March 12, 2014 Board of Education meeting, BBS and SCC will give a presentation on the status of bond. Projects proposed for Phase One, those that do not involve plumbing and electrical, have been submitted to NYSED for approval. Bids for Energy Performance Contracts (EPC) will be opened on Wednesday, February 19, 2014. Mr. DeTommaso congratulated Mrs. Susan Ellinghaus, formerly the Director of MAP, on becoming the principal of MAP.

Mrs. DeLauter advised the audience to review the future dates section of the agenda.

Under these circumstances, no student athlete will be allowed to drive to the event; should an athlete violate this rule, that athlete will not be allowed to participate in the practice or contest. (Please make all players aware of this policy.) Coaches are not to transport students using their private vehicles. The only exception to this is in a medical emergency.
