#### J. Unemployment Reserve Fund

  - c. The balance of this reserve fund shall not exceed \$750,000;
  - d. Expenditures shall be made from this reserve fund only for the payment of compensation and benefits, medical, hospital or other expense authorized by article two of the workmen's compensation law and expenses of administering the self-insurance program.
- 2. BE IT RESOLVED, that the Board of Education declares any amount greater than \$750,000 in the Workmen's Compensation Reserve (GML, Section 6-j) to be in excess and that the Board of Education approves a transfer of all excess funds in the Workmen's Compensation Reserve to the Capital Reserve (Ed Law, Section 3651).
