The meeting was called to order at 8:05p.m. Dr. Kaplan, Board of Education CALI President, welcomed everyone and led those present in the Pledge of Allegiance.

CALL TO ORDER

Mrs. Lanci moved that the Board of Education approve the minutes from the April 9, 2018 meeting. Ms. Gargiulo seconded and the motion was carried 7-0.

MINUTES

Mrs. Blane moved that the Board of Education approve the Treasurer's Report, for the month ended March 31, 2018. Mrs. Goller seconded and the motion was carried 7-0.

TREASURER'S REPORT

Dr. Kaplan honored a student's request to speak. Ian Kranis thanked the Superintendent, administration and the Board of Education and congratulated Dr. Kaplan's upon her appointment to the Community Council. He presented her with the framed newspaper article. He asked Board of Education student representative Rachel Katz to the prom and she accepted.

Dr. Kaplan stated a tenure reception was held earlier this evening marking this milestone in Bellmore-Merrick's teachers' and administrators' lives. They have become part of our family forever.

PERSONNEL

Mrs. Lanci moved that the Board of Education move up the Personnel agenda item and that the Board of Education approve the Superintendent of Schools' Personnel Report, dated May 2, 2018, as stated in the agenda. Ms. Gargiulo seconded and the motion was passed 7-0.

Dr. Bollettieri congratulated those receiving tenure and also the newly approved teachers.

Mr. DeTommaso congratulated tonight's tenure recipients and welcomed the new teachers. He formally introduced Gerry Owenberg as Principal of Kennedy High School starting July 1, 2018. Mr. Owenberg's parents were in the audience. Mr. Owenberg stated he is happy to be a part of the Bellmore-Merrick family.

Dr. Kaplan stated she is thrilled that Mr. Owenberg will be the next principal of Kennedy High School and thanked his parents.

STUDENT AMBASSADORS

Students from each of the district's schools who are involved in the Ambassador Program gave a history of the program and a review of this year's accomplishments. They meet quarterly and spread the One Voice, One Message theme throughout the district. They are involved in the Community Cupboard, participate in the Martin Luther King Day of Service, attend Human Relations Conference at Adelphi, tour the United Nations to understand its goals, hold many fundraisers and help each district school to qualify to become an Anti-Defamation League "No Place for Hate" school among other endeavors. Dr. Bollettieri had the committee members stand up to be recognized. She stated these student ambassadors have motivated the community to come together making the world a better place.

SUPERINTENDENT'S REPORT

Mr. DeTommaso thanked the Board, administrative team and the schools. He advised beginning in June, the district will open Wellness Centers at our two middle schools. These Wellness Centers will be open from 3:00-6:00 PM and staffed by psychologist, guidance counselors in partnership with hospitals. Students and parents will be able to deal with a wide variety of issues from scheduling problems and meetings with parents to counseling. The 2018-2019 School Budget provides for four new guidance counselors and three psychologists per high school. He thanked the Board, BMUST, Guidance Aps and the administrative teams for making this happen. He is looking forward to seeing this in action. Dr. Kaplan thanked Mr. DeTommaso on behalf of the Board for his leadership.

Mr. DeTommaso stated he is excited about this. It is game-changing and he appreciates the support. He mentioned some of the dates listed in the agenda and encouraged everyone to attend district activities and to view the artwork on display in the Central Office corridors tonight.

STUDENT REPRESENTATIVES

Rachel Katz of Kennedy was flustered by Ian's promposal. She congratulated Kennedy's tenure recipients. The Spring Concert and Spring Art Show were incredible. Kennedy's Virtual Enterprise (VE) team took 2nd place. A blood drive was held this past month and ten students qualified for National Merit Scholarship. She congratulated the Cultural Arts winners. A STEM Fair was held and additional students were inducted into the National Honor Society. The Cougar Invitational Track and Field event was held this past weekend. The Senior Fashion Show is scheduled for this week. She also congratulated Mr. Owenberg.

Gina Connors of Mepham also congratulated tenured recipients, stated additional students were inducted into the National Honor Society and named Mepham's Students of the Month. Sports teams are doing extremely well and four athletes competed in a Penn State University competition. Mepham's orchestra also competed at Virginia Beach and received awards. Students' work was presented at the Long Island Science Congress. The 10th Annual "So You Think You Can Dance" was held. Videos of these events can be found at Mepham Broadcasting. A self-defense program, health career options fair and the NYC Scavenger Hunt are upcoming. Two students competed in an Italian Poetry Recitation competition. LGBT is hosting a cultural night this month.

Mr. DeTommaso stated all six district schools have been designed as "No Place for Hate" schools by the Anti-Defamation League.

Jordan Ladd of the Meadowbrook Alternative Learning Program (MAP) advised students had a trip to Sagamore Hill. Students are working on the green house and food from the hydroponic garden has been given to the Community Cupboard. Students attended a live production at the Port Jefferson Theatre. Leadership class students went to the Newbridge Road School. Yesterday was College Decision Day and students and staff wore their school's clothing. She announced she is this year's Valedictorian and Chazz Opperman is the Salutatorian.

Ted Tanenbaum questioned the Superintendent's remarks regarding previous Boards of Education. He questioned how the proceeds from the sale of Jerusalem Avenue will be used. He asked if the district would consider using the proceeds from Jerusalem Avenue to pay off the bond. He stated since all districts pay into BOCES, this district will still be paying for Jerusalem Avenue.

Mrs Goller moved that the Board of Education convene the public hearing for the 2018-2019 School Budget. Ms. Gargiulo seconded and the motion was carried.

PUBLIC HEARING – 2018-19 BUDGET

Mrs. Kate Freeman, Assistant Superintendent of Business, gave a brief Powerpoint presentation. The combined total of the three part 2018-2019

budget is \$159,788,043. Benefits, debt service and retirement contributions have increased. The district will receive approximately \$1,000,000 in New York State aide. Proposition II is funded by a reserve and will have no tax impact. The tax levy is at .265 and budget to budget is 3.98. A Contingent Budget would require the removal of \$3,000,000 from the budget.

Dr. Kaplan thanked Mrs. Freeman and her staff.

OLD/NEW BUSINESS

There was none.

Dr. Kaplan wished everyone a Happy Mother's Day and reminded everyone that the Budget Vote is May 15, 2018. She encouraged everyone to get out and vote.

EXECUTIVE SESSION

On a motion by Ms. Gargiulo, seconded by Mrs. Blane and carried 7-0, the Board of Education entered into Executive Session to discuss a confidential matter at 9:10 p.m.

On a motion by Mrs. Blane, seconded by Mrs. Lanci and carried 7-0, the Board of Education reconvened at 9:20 p.m.

ADJOURNMENT

On a motion by Ms. Gargiulo, seconded by Mr. Ferraro and carried 7-0, the Board of Education meeting was adjourned at 9:21 p.m.
