4. Superintendent's Report

Mr. Harrington welcomed everyone and said that the buildings were filled with spirit, energy and excitement and we are off to a great start of the school year. He said last week we welcomed back our teachers at Superintendent's Conference day with an amazing performance from the Calhoun Rock Band which was a reminder of the programs and opportunities that our students are offered.

Mr. Harrington explained this year's theme of The Power of Yet which is based on a book, "The Magical Yet", which is about a magical creature that helps a child welcome challenge, take a new path, learn perseverance and persistence and changing our thoughts to I can't do that YET. Mr. Harrington said we will push further when talking to kids about making good choices and how they will help make this district even better. He thanked the Principals and Assistant Principals who worked very hard to make transitions smooth. He also thanked the Directors for working so hard this summer to ensure our buildings have everything they need.

Ms. Hollings, Principal of Calhoun High School discussed the opening of school and said there was great energy. She said the 9th graders were smiling and looking forward to starting in the building. She said we have great things coming up, such as homecoming and On-Tour productions and that it is going to be a great year.

Mr. Arlin, Executive Director of Alternative Education said that we welcomed 50 students in the Meadowbrook Alternative Program this year and 24 students in Prep Academy. He said he is excited about the opening of the expanded Electrical Program for 11th and 12th grade cohorts and that there are about 50 students in the program. He said it was a great opening and he is looking forward to great things.

Ms. Dunn, Principal of Merrick Avenue Middle School said there was fantastic spirit. She said the 7th graders were nervous but orientation helped ease some of their nerves. She said she loves the message of YET and our culture of "Ramily", and she will ensure our kids feel that. She said over 500 students are looking to participate in sports this year. She thanked the staff for all of their work over the summer and said she is looking forward to a great year.

Mr. Owenburg, Principal of Kennedy High School said Kennedy has alot of "Kennergy"! He said student and teachers were recharged over the summer and we saw great spirit on the first day. He mentioned how the seniors come in full of spirit with their cars decorated and it was nice to see that spirit trickle down to the freshman. He said they are getting ready for fun events like homecoming and they are off to a great start.

Mr. DeMartinis, Principal of Mepham High School said it has been a great start to the school year. He said 9th graders jumped in right away and that teacher, counselors and staff all helped with lockers and giving the students directions to their classrooms. He said the students did the morning announcements and it was so nice to see kids growing into their senior year. He said Senior Sunrise is on Friday and students will enjoy bagels and watching the sunrise together. He said next week counselors will meet with 9th graders and will be reintroducing themselves to the 10th and 11th grade students. He mentioned that there was a small fire in the building last week and thanked Mr. Simpkins for all of his hard work getting everything ready for opening day. Mr. Conte, Principal of Grand Avenue Middle School said 7th graders were nervous about their lockers and where their classrooms were but within a few periods of the day we already saw teachers having connecting conversations with kids. He said that humanities lessons will start next week, adding that is is an incredible time to connect with kids and they will include conversations about September 11th. He mentioned some of the projects that took place over the summer and thanked everyone for their support and he is looking forward to a great year.

A. Curriculum, Instruction and Data Presentation - 2022/2023 Academic Year In Review

Mr. Bersin gave a PowerPoint presentation on 2022/2023 Academic Year in Review and said last year was a great year and that we saw growth in our educational programs. He discussed AP exams and how we look at the participation rate relative to Nassau County and explained that students are participating more than the average across Nassau County. He said the district's educational programs have grown and we see that growth in our specialty programs. He said kids are being encouraged to do more and we are seeing tremendous academic success. He explained that in every regents course we were well over the county and State averages. Regarding AP exams, the district had a great passing rate but we are more interested in getting more kids into the programs. We have seen lots of areas of strength, growth in statistics and we are seeing enrollment increasing as kids take more challenging classes. He said that we had a graduation rate of 98% and that 82% of students received an Advanced Regents Diploma.

Mr. Soel explained that the Physics C - Mechanics AP exam has a low participation rate because this is a college level, combined physics exam which allows students the opportunity to sit for the exam without taking the course. He said we are one of maybe 7 school districts that even offer this to our students.

The Board of Education had some questions and Mr. Bersin explained that the information presented tonight does not include duel enrollment college courses that are being taken by students at any given point. He further explained the summer programs and how the graduation rate has increased. When asked about equity and access to AP exams, Mr. Harrington explained that for students who can't afford AP exams the district has funding for them.

Ms. Dunn discussed the Advisory Program for the middle schools, a program that was created so students feel as if they have at least one trusted adult that they connect with in the district. These types of programs improve emotional and mental heath in students. She explained that most class sizes have about 26 students and the Advisory Program will have small groups at least once per month for each student. She explained that during these sessions they will be talking to the kids about being good students and good community members. She said that teachers are excited to have these smaller classes and to teach these lessons, they are really looking forward to the program. Mr. Conte explained that this program will give students an opportunity to stop certain bad behaviors and will look at different ways to discipline our kids in hopes of turning the tables for them. Ms. Dunn explained that we want to be more mindful of students to have at least one adult they connect with and that this is not typical curriculum writing. She said four lessons have been written at this point. The first session included discussions about where you are in life and the second lessons focuses on "The Magical Yet". She said that they are mindful about what should be taught at home and what is taught in school and these lessons are about community and belonging and similar types of things that may come up such as hate speech. Mr. Conte added that each lesson plan has two adults present in the room as a fail safe to ensure that things don't go astray.

In response to questions from the Board of Education about restorative justice, Mr. Bersin said that there will be a more restorative type practice and that curriculum has been written so that we aren't just dealing with consequences of actions.

Mr. Bersin ended by saying we are looking forward to more great things, that it is a real honor to be in this district and that we will have our kids meet their goals.
