Mrs. Piskin presented an Award of Honor certificate to Max Bazil for receiving the 2016 Child Mind Rising Scientist Award. Max is a senior in the Advanced Science Research program. His interests in medicine led him to become Captain of the Junior Squad at the Bellmore-Merrick EMS Station, where he was inspired to pursue clinical research after previous interests in biochemistry. He works as a volunteer researcher at Mount Sinai Hospital's Department of Neurosurgery developing a model to interpret and analyze millions of images stored within every hospital database in the world that could not be previously measured. By

analyzing thousands of patients and hundreds of images depicting the internal carotid, middle cerebral, and anterior cerebral arteries, Max was able to derive such a model and has presented at the Long Island Science Congress as well as submitted his own research paper for publication in the Journal of the American Neurological Association. He is currently working to integrate his model into hospital machinery and provide professionals with the information that may one day save lives. In addition to the Research Program, Max is also a member of several National Honor Societies, the Math Olympiad and Debate teams, the varsity Cross Country team and plays numerous instruments. He also enjoys mountain climbing, astrophysics, running and glass blowing. Mrs. Piskin congratulated Max on behalf of the Board.
